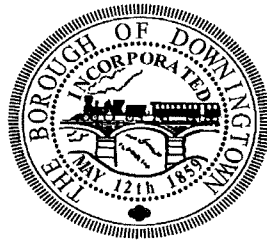

Failure to tender the fee at the time an intervenor seeks status shall be a sufficient basis to deny the application for status; failure to pay a subsequent fee prior to the time of the scheduled subsequent hearing shall be sufficient basis to deny the Intervenor the right to participate in that or further proceedings.)

**Zoning Hearing Board Matters (Intervenor fees)**

- Zoning applications regarding up to three residential uses: \$100.00
- For each second or any subsequent hearing following first hearing: \$ 50.00
  
- For applications involving any uses other than the above: \$250.00
- For a second or any subsequent hearing following first hearing: \$100.00
