

ORDINANCE 2018-01

**BOROUGH OF DOWNINGTOWN
CHESTER COUNTY, PENNSYLVANIA**

AN ORDINANCE AMENDING CHAPTER 199-5C, PARKING, RESIDENTIAL PERMIT: RESIDENTIAL PARKING PROGRAM PROCEDURES, AND ADDING SECTION 199-10, PARKING, RESIDENTIAL PERMIT: JEFFERSON AVENUE PARKING DISTRICT, TO CREATE THE JEFFERSON AVENUE PARKING DISTRICT.

AND NOW, this 2nd day of May, 2018, it is hereby Enacted and Ordained by the Borough Council of the Borough of Downingtown, Chester County, Pennsylvania that:

SECTION 1. Section 199-5C of the Code of the Borough of Downingtown is hereby amended to add the following “Street” and “Location”.

<u>Name of Street</u>	<u>Location</u>
Jefferson Avenue	See §199-10 for location descriptions

SECTION 2. The following new section is added to Chapter 199 of the Code of the Borough of Downingtown.

Chapter 199-10: Jefferson Avenue Parking District.

The Jefferson Avenue Parking District identified in 199-5C shall be subject to the program and procedures set forth in Chapter 199, except as to the following standards which shall supersede all other standards and regulations as to the Jefferson Avenue Parking District only:

A. The Jefferson Avenue Parking District shall consist of forty (40) parking permits, whereby two permits shall be issued to each residence with street frontage on the 100 Block of Jefferson Avenue, and permits shall be issued to the following identified house numbers subject to other applicable terms and conditions of Chapter 199.

- (1) Permits 1 and 2: 109 Jefferson Avenue
- (2) Permits 3 and 4: 113 Jefferson Avenue
- (3) Permits 5 and 6: 115 Jefferson Avenue
- (4) Permits 7 and 8: 117 Jefferson Avenue
- (5) Permits 9 and 10: 119 Jefferson Avenue

- (6) Permits 11 and 12: 121 Jefferson Avenue
- (7) Permits 13 and 14: 123 Jefferson Avenue
- (8) Permits 15 and 16: 125 Jefferson Avenue
- (9) Permits 17 and 18: 127 Jefferson Avenue
- (10) Permits 19 and 20: 151 Jefferson Avenue
- (11) Permits 21 and 22: 153 Jefferson Avenue
- (12) Permits 23 and 24: 155 Jefferson Avenue
- (13) Permits 25 and 26: 157 Jefferson Avenue
- (14) Permits 27 and 28: 159 Jefferson Avenue
- (15) Permits 29 and 30: 161 Jefferson Avenue
- (16) Permits 31 and 32: 163 Jefferson Avenue
- (17) Permits 33 and 34: 165 Jefferson Avenue
- (18) Permits 35 and 36: 167 Jefferson Avenue
- (19) Permits 37 and 38: 169 Jefferson Avenue
- (20) Permits 39 and 40: 171 Jefferson Avenue

- B. Each dwelling unit in the Jefferson Avenue Parking District is eligible to be issued one guest card.
- C. Vehicle exemptions from permit requirements under §199-5F shall apply.
- D. The Jefferson Avenue Parking District parking permit program shall be in effect twenty-four (24) hours per day.
- E. The Jefferson Avenue Parking District signage, otherwise subject to Chapter 199 in terms of violations and enforcement, shall read:

**RESIDENTIAL PERMIT PARKING ONLY
24 HOURS PER DAY
7 DAYS PER WEEK**

SECTION 3. Effective date. This ordinance shall be effective upon enactment as provided by law.

SECTION 4. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of Borough Council that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION 5. All ordinances or parts of ordinances conflicting or inconsistent herewith are hereby repealed.

SECTION 6. General Code is hereby authorized to make non-substantive formatting and numbering changes necessary to clarify references to other sections of the Downingtown Borough Code and to bring the Ordinance into conformity with the Downingtown Borough Code.
