CU 2021-001 Mission Community Church

The applicant proposes to purchase 216 E Lancaster Ave for the use of its Church. This type of use is approved for the C-1 Zoning District but they will be seeking shared parking approval from Council. Agreements with MSV, 15 Green and 216 Washington will be submitted. After discussion the planning commission is recommending to Council that they not make a final decision until the PC has the opportunity to meet with the Applicants or not approve a reduction in required parking or have the applicants pay a fee-in-lieu for the shortage in parking.
