Approval of Minutes

There was not a quorum (Lauren Van Dyk and Dave Proctor were not at the April 15th meeting) to approve the minutes of April 15, 2019 so approval was deferred.

Trestle View - Applicant Update

Francis Taraschi gave an update on the project and stated that the Borough has requested a decrease in the density for the project to 60 units. The applicant stated that he would be willing to decrease the density for this project from 79 to 75 units. Lauren Van Dyk asked that the walkways and homes along Prospect be facing the front to give the project a neighborhood feel. Mr. Taraschi discussed how Green Street has the same look and he did not feel that would be a problem for Prospect Avenue to have that same look and give it a friendly neighborhood feel. The Planning Commission thanked the applicant for the update and look forward to seeing a revised plan once the density is determined.

SD 2019-001/310 William St - Brenenborg

The Applicants along with their builder met with the Planning Commission to present their Sub-division plan. They are proposing to divide the lot into three separate lots with an existing twin home on one lot and building a twin home on the two additional lots. Matt Bush (Borough Engineer) discussed the second review completed along with certain waivers being requested. Steve Miller made a note that the name listed on the plan for the property to the East is incorrect. After discussion with the Planning Commission, Eileen Moyer made a motion, seconded by Steve Miller to approve the Application. Motion Carried.
